

**FSY23** This past fiscal year has been very productive. Despite what we have been able to accomplish there have been some barriers to implementation. It was underestimated how much administrative power it takes to network, create, and plan mezzo and macro-level programming. While finding partners and getting everyone in agreement to work together was fairly easy for LC CFFC, the details are taking much longer than expected. Other than manpower to complete the shared plan, I am very excited to document all that has transpired with Council this past year.

2. Identify any successes/how implementing this plan has worked to strengthen the council and county collaboration.

**FSY23** LC CFFC is becoming a household name within the communities and county providers. This has been no easy accomplishment. It has taken Council members time and effort to make connections and collaborate. There have been several huge successes I want to document.

Success- For the first time Lorain County Public Health, Lorain County CFFC, and Lorain County Job and Family Services are partnering to support/implement a Plans of Safe Care Program. With LC JFS as the main funder and a small contribution from PH and CFFC there will be a multitiered service coordination program where pregnant mothers who are struggling with addiction and or newly born infants that test positive for a substance can receive high-level services to stabilize families and prevent custody relinquishment.

Success- The creation of Lorain County Youth and Family Collaboration is a team of administrators/ directors representing core agencies that work with multi-system youth. This collaboration was created to prevent duplication of services, discuss working collectively, and hopefully soon a platform for providers to "present" complex cases to obtain feedback and solutions from a county narrative.

Success- Almost every single school district within our county including the vocational school has gone into an agreement with the Lorain County Education Service Center where they are receiving free services from the wellness coordinators to create suicide prevention policy work as well as Columbia Suicide training for the school counselors and social workers. This is a huge partnership as one of the agreement measures was for

Council to obtain data from the schools in regard to referrals, needs/trends with mental health assessments, and other data deemed relevant for the work of Council.

These successes have helped Council with stability, overall purpose, and have strengthened its role within the County.

We are expected to see double the families involved within the Plans of Safe Care Program over the next year as well.

There are steady referrals for Councils services for consultation, service coordination, and high-fi wrap-around. We are receiving referrals from all different kinds of agencies including large hospital systems, therapists, local doctors, schools, and self-referrals! Despite OhioRise we are still finding CFFC eligible MSY that need our services. A much younger population as well.
